There are avenues to help you and your family manage through this difficult time. While all businesses in the bushfire zones share common concerns, how you choose to respond will depend on your unique circumstances.

Our Rural Financial Counselling Service (RFCS) supported farmers, growers and small ag-related businesses through the recovery phases after the Sampson Flat and Pinery bushfires.

Our professional and empathetic staff can sit with you, in a place of your choice that's convenient and comfortable, and help you and your family plan a proactive response to this traumatic event.

What do we do now?

It is normal to feel overwhelmed by a disaster event of this scale.

Step by step, we can assist you in prioritising what needs to be done next and to take action, even when it feels difficult knowing where to start.

We can help you to:

- Prepare for talks with insurance companies, banks and lenders
- Prepare cash flow forecasts to meet financial obligations
- Access other professional services
- Develop and implement plans to return to 'normal' operations

Options to think about

In terms of cash flow and recovery for your business, planning will be critical in making decisions and talking with financers. This is where we can help.

It may be worth talking with your lenders about what assistance they can offer. Is there an interest-only option around finance structures?

We can work with you to develop a plan for the next 12 to 24 months, talk through what your business requirements will be and look at how these might be managed financially.

Any concerns about the tax implications with monies you may receive via donations or insurance payments should be raised with your accountant or the Australian Taxation Office (ATO).

RBS also has information on programs that may be available to you such as Farm Household Allowance (FHA) and emergency aid through the South Australian Country Women's Association (SACWA), Red Cross, Salvation Army and St Vincent de Paul.

Disaster Recovery Payment

The Australian Government Disaster Recovery Payment is a one-off payment to help you if a declared disaster significantly affects you.

If you are eligible you will receive \$1000 per adult and \$400 for each child aged under 16 years.

Other Government assistance

Sometimes rural businesses need an extra hand during tough times.

FHA provides eligible primary producers and their partners with fortnightly income support for up to four years.

You do not have to be in a drought area

to apply. If you've decided to apply for FHA, you will need to set up a MyGov account if you don't have one already. You can do this at https://my.gov.au.

The <u>Regional Investment Corporation</u> (RIC) provides farm investment loans to improve the strength, resilience and profitability of eligible farm businesses.
